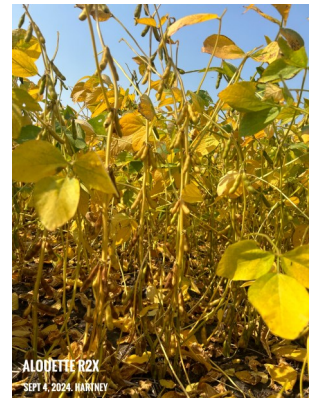

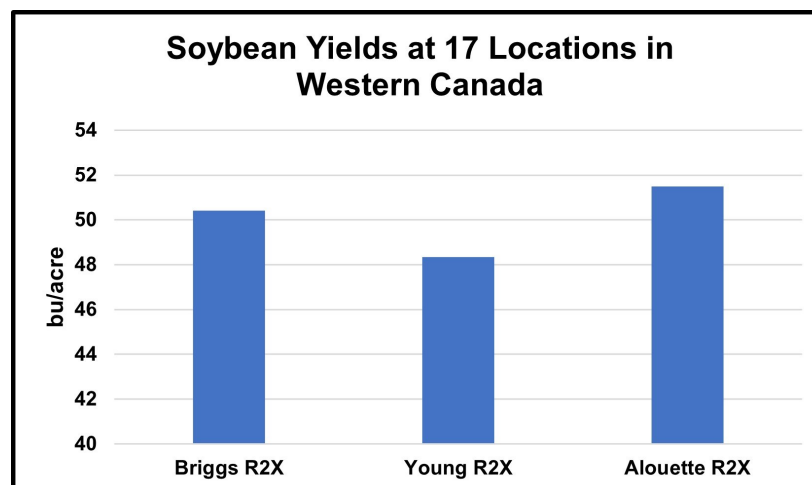

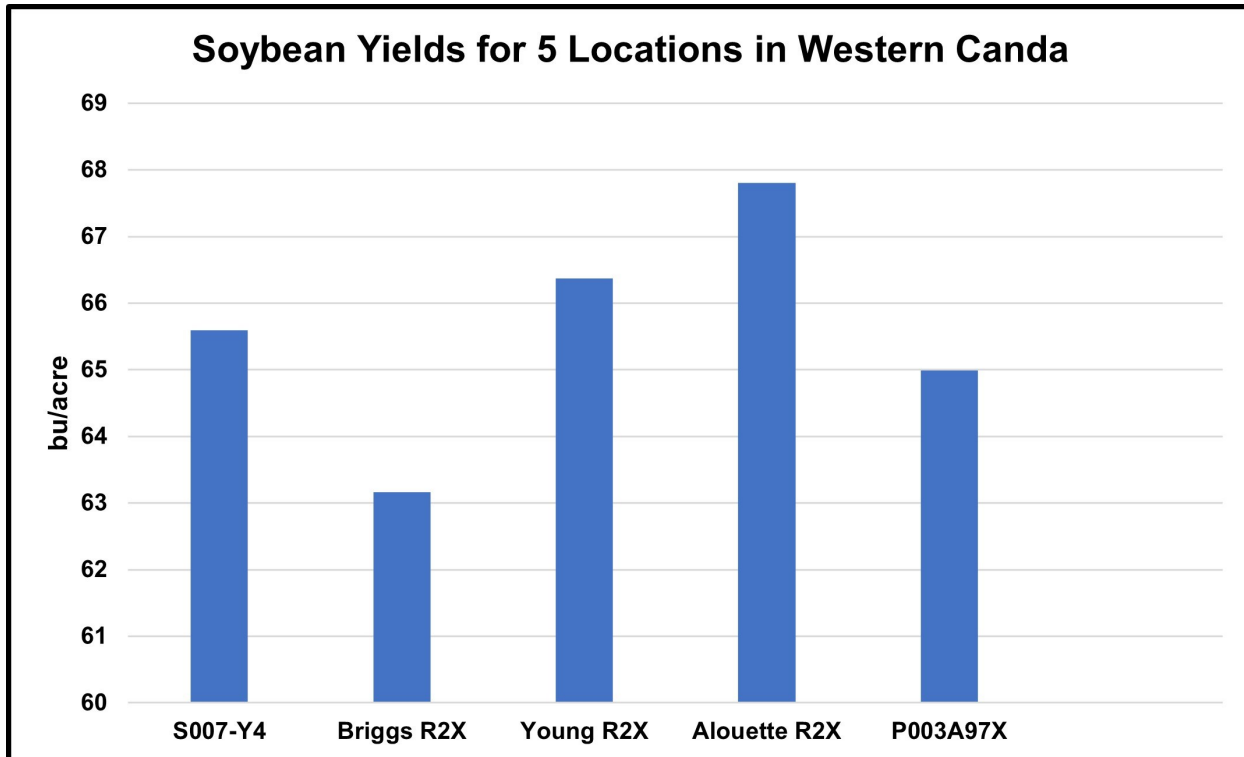


COMMENTS

Alouette R2X is a new Roundup Ready 2 Xtend[®] soybean variety with medium maturity. Alouette R2X is a medium tall plant with good standability. It has a great ability to branch out and fill in space when seeded thin or the case of poor emergence. Its IDC rating was 1.8 from MB Agriculture, giving it a solid semi – tolerant (ST) rating.

- Medium/tall height, with a bushy plant type and great lodging tolerance
- Great bottom pod height
- Strong first year yield results on a field scale
- Solid phytophthora and IDC make this a very defensive bean!
- Dicamba provides excellent control of kochia, ragweed and wild buckwheat
