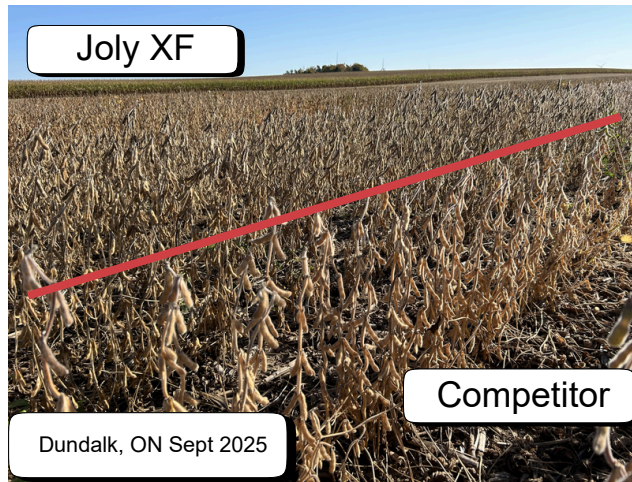

Industry leading Phytophthora field tolerance.

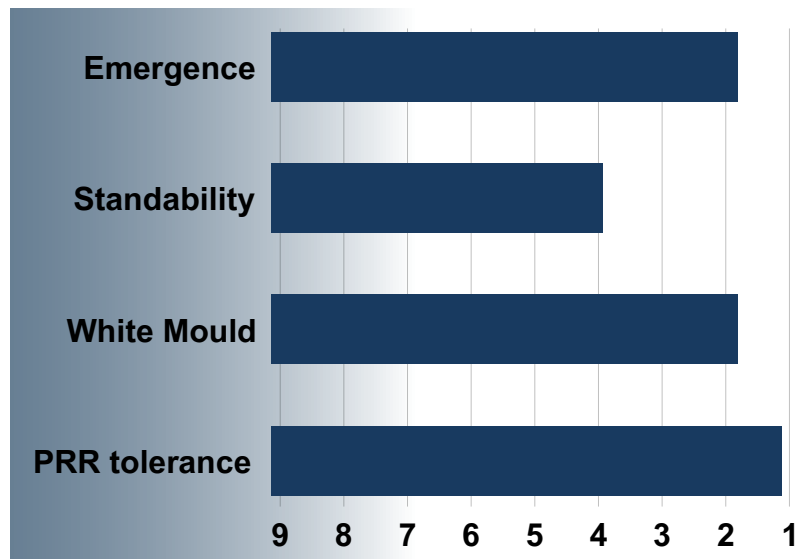
