Great addition to the Xtendflex trait system with Peking SCN resistance. Broad adaptation. Roenick XF has top-end yield potential but also the ability to go on lower yielding acres with robust plant type.

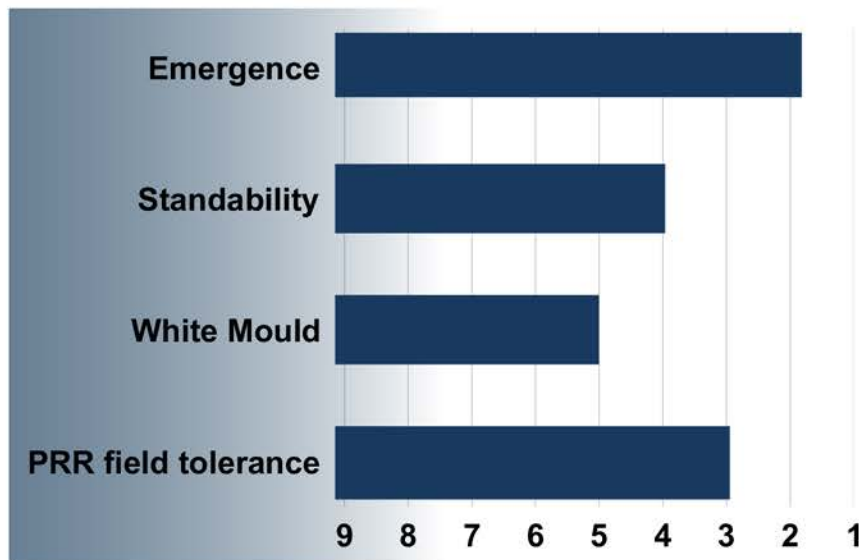
