## COMMENTS

Briggs R2X is a new Roundup Ready 2 Xtend<sup>®</sup> soybean variety with early maturity. Many early maturing varieties are short and hard to harvest, but Briggs R2X is nice and tall and stands well. Briggs R2X is also a nice bushy plant with good branching to compensate for poor patches within fields. It's IDC rating was 2.0 from MB Agriculture, giving it a ST rating. We look forward to seeing its yield in Seed Manitoba this year!

- Medium/tall height, with a bushy plant type that stands great!
- Great first year yield results on a field scale
- Cyst nematode resistance gene and phytophthora and IDC make this a very defensive bean!
- Dicamba provides excellent control of ragweed and wild buckwheat
